## Information and reminders - The first half term

### Following appointment of an NQT

If your NQT has not started at the beginning of term, organise a school visit to meet key staff, prior to taking up an appointment. Ensure NQT is provided with all necessary planning and policy documents and invite NQT to attend 'new staff induction' events.

### Within the first four weeks:

- Arrange a meeting to discuss Career Entry and Development Profile (they will have completed this at the end of their teacher training)
  regarding identified training needs
- Complete first generic action plan
- Arrange to meet NQT on a weekly basis to discuss progress
- Ensure NQT has met key staff and clearly understands school processes e.g. assessment, parents' evenings etc.
- Organise an observation of the NQT
- Plan how the NQT will use 10% release time (at least for first few weeks after that please ensure it is done in advance rather than "what did you do in your NQT time"
- Plan first professional review meeting to take place by half term. When and where?



### **Portfolio of NQT Documentation**

This document details the evidence that should be kept/ recorded. The documents should present the 'story of induction'.

### **Record of Professional Review**

Regular mentoring meetings with the Induction Tutor are a key element of the induction process. They help the NQT to feel well supported and enable the Induction Tutor to fulfill their statutory responsibilities.



### **NQT Manager**

SIPS has invested in NQT Manager which is a web based online system that has the following benefits:

- Auto fill of NQT contract information when they fill in an assessment
- Easy access to old assessments when filling in new ones to see what was written previously
- Automated notifications when assessments are coming up and reminders if they are overdue
- Easy to save and come back to later
- Quick and easy access to view information about their NQT's induction year, for example when their next assessment is due, or when they are due to finish
- Easy access to Appropriate Body documents such as handbooks, guides to the standards etc.
- Completely online, so it's accessible from anywhere home, school, coffee shops etc.
- Easy communication with SIPS as the Appropriate Body
- NQTs, tutors and head teachers all complete their parts of the assessment online and can see the other parts
- Easily update an NQT's details, change tutor etc. and the Appropriate Body will be automatically notified
- Automatic TRA Employer Access check during registration to ensure that NQTs have QTS
- Safe and secure
- Everything is stored permanently online for you there is no need for printing or posting of assessments and registration forms
- Platform independent, so no matter what type of IT infrastructure your school operates, they will always be able to access and use the system

**Refresher Induction Tutor Training** 13 September 2019, 13:30 – 16:30


#### **Content Summary**
